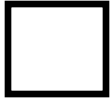


FIESTA ISLAND YOUTH CAMP RULES



- **Family camping is not permitted.**
Per the permit only Youth Groups and Leaders.
- **Permit must be on site and available at all times.**
- No RV's or 5th wheels permitted at any time. **TENTS ONLY.**
- There are three (3) loading zones within the Youth Camp.
- If you are not **ACTIVELY LOADING/UNLOADING** you **MUST** park in the main lot.
- Overnight parking in the loading zones is prohibited.



- **ALL VEHICLES** must park in the **MAIN LOT ONLY.**
- Park **within** the **MARKED STALLS ONLY** in parking lot.
- **RED ZONES: NO PARKING** (no loading/unloading) **AT ANY TIME.**
- **TURF** or **WITHIN CAMP SITES - NO VEHICLES ALLOWED AT ANY TIME.**
- Parking is first-come, first-served.
- No overnight sleeping in vehicles.
- **PARKING VIOLATIONS WILL BE SUBJECT TO A CITATION**
- **ALL FIRES** must be in City provided fire rings.
- **EXTINGUISHING FIRES** - Please use **WATER** not sand.
- **CLEAN WOOD ONLY** allowed in fire rings (e.g. no pallets, nails, paint, chemicals, tree clippings, cardboard, etc.)



- **BIKES ARE ALLOWED** on **ROAD ONLY.** Do not ride within the campsites.
- **NO ALCOHOL, NO SMOKING, NO GLASS, NO DOGS.**
- **NO DECORATIONS, NO SIGNS, NO CLOTHESLINES ATTACHED TO CITY PROPERTY.**
- **NO WATER BALLOONS, NO FIREWORKS, NO ROCKET LAUNCH (PERMIT ONLY)**
(Environmental / Wildlife protection)
- **STAY OUT OF REVEGETATION AND SENSITIVE HABITAT AREAS.**
This includes the small island with the palm tree.
- Amphitheater is **RESERVATION ONLY.**
- Group picnic area is first-come, first served.
- **Please properly dispose of all excess trash in the dumpster by the group picnic area.**
- **NO USE OF CITY ELECTRICITY IS ALLOWED** (including outlets on posts).
